General meeting of the Association

MINUTES 13th March 2017

WELCOME. Chairperson Elena welcomed members, TDC councillors and TDC staff to the meeting.

OPEN FORUM (3 minutes):

- Rob Smith. Goundwater Scientist for Tasman. For members information. Will be drilling a deep monitoring monitoring bore in April/May. Will advise where it is going to go.
- Bruce Thompson. Footpath, Mapua Drive. Needs repair. 2. Signs by Tahi St Green area, saying no overnight parking. Feels this is a little negative.
- Hugh Gordon. Anniversary, 44 years ago today, arrived in NZ with his family. Spoke about how he feels about living in NZ but urged people to speak up at meetings about issues affecting them and their community.
- Naomi Aporo . Thank you. Been in Mapua since Sept. Spoke about how she feels about her new community.
- Jane Dillon new Mapua resident. Cyclist and footpath issues.
- Mike Kininmonth. Questioned TDC staff about the results of the survey.

PRESENTATION SLOT. TDC Strategic Plan. Presentation and discussion from TDC Mayor, Richard Kempthorne, Councillors and TDC staff as listed above.

- Mayor Kempthorne spoke first, giving an overview of the TDC's current situation. Seeking input from community prior to next LTP from 2018. Invited questions about the Annual Plan. Several MDCA members asked questions relating to: Golden Bear toilets, Liquor Licence and toilet requirements, Capital Works Programme budget and expenditure, balance sheet PNL growth and revenue tracking, Mapua water connections including the possible supply from Motueka and the proposed Waimea Dam, level 4 waterways in the region, freedom camping, reserve land plans for Seaton Valley, entrance to Mapua and traffic flow, Mapua bus service, signage to Mapua village at the Higgs Rd roundabout and community development projects & coast care, Noting Beryl Wilkes (TDC Parks and Reserves Manager) unable to be present but would respond to this latter two questions.
- Jamie McPherson then spoke about projects around roads and pathways.
- Mike Schuer talked about water and waste water and invited questions.

Elena then thanked the TDC for their attendance and the meeting took a 5 minute break.

Elena Invited Rob Smith to speak further about groundwater monitoring and the proposed monitoring bore as mentioned in the open forum. Bore hopefully to be drilled in April. Noted there are around 40 *monitoring* bores around the region.

TDC website now open for submissions on TDC charges and the LTP. David Mitchell queried whether the MDCA was planning a collective submission. Elena asked the meeting for an opinion. AGREED that at the April MDCA meeting, this will be discussed and a submission formulated.

MINUTES PREVIOUS MEETINGS- Assn & Exec. Exec notes from the Feb 23rd meeting were TABLED. Assn February minutes: Noted that Reinhard Gebhard spoke in the Open Forum slot at the Feb meeting, not Mike Kininmonth as recorded. Moved **THAT** the amended minutes of the Association's general meeting held on February 13th 2017 were an accurate record of that meeting Trish Smith / Helen Bibby **CARRIED** Action & follow up ROADS & Jamie McPherson spoked during the TDC presentation. Wayne referred to this **Wayne Chisnall PATHWAYS** and no further update on this portfolio. **1.Proposal for revision of Constitution** – reminder of shared input session at end of April 2017 meeting ASSN RULES & CONST. MAPUA Waterfront Park Upgrade Working Group meeting - verbal update from Trish WATERFRONT Smith. Next meeting, early April. Noted that the CUG representative, John & WHARF Fountain attended the WPWG meeting. Meeting noted that the WPWG is a subcommittee of the MDCA as different from the Waterfront Advisory Group which was established for businesses and the community to liaise with TDC, meets every three months and is currently chaired by Cr Tim King. MDCA submission discussion from Feb meeting – update. Noted there will be a summary of responses available from TDC from the 23rd March – on their website and a copy will be sent to the MDCA. Waterfront Advisory Group. Trish Smith (MDCA rep) noted discussion about the TDC consultation process, lighting and progress on the Golden Bear lease requirements. Reinhard Gebhard spoke about extending neighbourhood representation for the WAG. Elena noted that the meeting strongly mandated the neighbours' representatives to liaise with all the waterfront neighbours. Cr King also spoke on the issue of representation and other avenues to have input into future developments on the waterfront. COUNCIL Colin Walker Cr King was asked to respond to the discussion (open forum a/a) about Freedom FEEDBACK Camping. He also noted that the current process of a 6-weekly wait for meetings & REPORTING from TDC meetings was being investigated to see if it could be speeded up and talked about the issue of safety on shared pedestrian/cycle ways. Suggested we ask Jamie McPherson about stencilling options for the shared footpaths. ENVIRONMENT Waimea Inlet Forum Report. No update. **Helen Bibby** AL PROJECTS Replanting Mapua Drive Roadside & Dominion Flats Mamaku Dr Helen Bibby gave a short verbal update. **FUTURE Dale Vercoe land gift.** No formal update but Elena noted a recent news item.
