The following comments with regard the draft concept plan for temporary carparking in Mapua for this summer from the MDCA Exec meeting last night are -

- 1. That entry into the parking area is off Tahi Street with an exit being on the northern boundary onto Aranui Road in an attempt to reduce the traffic volume at the round-about.
- 2. That a pedestrian access gate be provided into & out of the car park in close proximity to the north eastern corner.
- 3. The centre parking spaces be wider so as to accommodate the full width of campervans & other larger vehicles to enable their doors to be opened without risking damage to vehicles parked alongside.
- 4. The southern side of the entry gate is reserved solely for boat trailer parking.
- 5. The yellow no parking lines on Aranui Rd be extended.
- 6. Clear directional signage is in place

Please note: MDCA request when longer term solutions to ease the pressure of vehicle flow & parking in Māpua during the tourist season that much thought, consideration & alternative methods are found to minimise the need for cars to park close to their destinations.
