General meeting of the Association MINUTES [10 December 18]

WELCOME. Chairperson Marion welcome.

OPEN FORUM (3 minutes):

• Devon - Speed limit through Mapua getting worse. Perhaps better signage. Can MDCA write to TDC? Wayne did write but came back and said it's not such an easy process. Jamie has measured the speeds and traffic volumes. Comes down to evidence to support request.

Richmond example designed for 30km. Brightwater street designed for 40km according to certain elements that narrow the road. Aranui Road not designed for 30km zone. Aranui upgrade due 2024 when street gets reconfigured to adapt to lower speed. Increasingly main streets of towns carry more traffic.

Tim Hawthorne – put up a speed limit and you would expect people to obey the laws. Tim King – local people are the worst exceeders putting up a sign will never magically fix it. You can write and ask but will come down to design of road.

Helen – suggest to write to council to ask if a sign can be put up prompting motorist to slow down. Motion put forward by Helen Bibby / Second Elena Meredith

• David – Need for a toilet on Rabbit Island side of Mapua Ferry wait area. David already wrote a letter to TDC and will forward that to MDCA. Request MDCA to support his request for toilet facilities. Question raised whether it is a council issue or business (Trail Journey) issue. Tim King mentioned that toilet facilities has been suggested on various occasions with the challenge being that it is a 100km trail. TK suggest to prompt business to approach or apply for funding from TDC. There has been an application for planting on that side that TDC is supporting. Discussions with the ferry people will be good as it's more than just the cycle trail. They already build a ramp. Notion is that Mapua Ferry people would support the idea of toilet facilities on that side but would need financial support from TDC. Elena – recall some issues with having toilet on dune. Cycle trail people put notice on toilets to say last toilet (sign is there). Many tourist, however, miss the sign and therefore the need for such a facility closer to ferry waiting area.

From Naomi - historical and cultural significant can imagine huge challenges as previously a fishing village

Way forward – write and ask cycle trail trust if they have any plans of doing anything. Mention there's been concerns. The first step, however, is to gather more information (speak to Trail Journeys, Mapua Ferry).

PRESENTATION SLOT. Marion introduced

• Glen Thorn – Mapua playground upgrade

Funding allocated in this financial year – survey been distributed among the community. Once surveys come back the task would be to collate feedback

Timeframe – June 2019

Consultation out Dec-Feb

Month to collate feedback

12 Weeks to source equipment before work can commence

Consultation of children important. MDCA survey amongst schools and play centre around work to be done at Waterfront Park. Found best ideas coming from children using playground and not necessarily parents or caregivers.

Budget \$153 000 factoring in the removal of what is there already. Can be sold rather than be donated as it's at end of life. Same footprint – idea is to extend a little to make maintenance easier and provide more seating under shade.

Q: What was the budget for Takaka playground?

\$120 000 Some criticism for playground as main structure came from Germany.

Example - problems with doing a themed wooden playground, like sea based as it is easier and more cost effective for TDC to import already designed and safety approved equipment. Saves council fees as it won't require building permit, etc.

Q:Thoughts about more secured fencing around playground

TDC not a big fan of fencing. Rather strategically place furniture to form natural barrier.

Design to create safe zones or through zones – strategically place equipment to cater for all ages. Upper Moutere playground for example toddler area too far away from bigger kids' area. There is value in cross playing (big kids with smaller kids) but there's a skill to how that is integrated.

Q: Question around design being consistent with Mapua Waterfront conversation and narrative around whole of Mapua.

Naomi want to know if the historical and contemporary narrative is kept in mind — looking for unique opportunity to tell story to all ages through design. How will design incorporate that theme into playground equipment? Naomi mentioned Harakeke incorporation and asked from Maori perspective, what information would be required to be considered in the design? Are there opportunities for incorporation in new paths telling a story, giving greater meaning than just serving as a foot path?

TDC reply: Sounds exciting – we can't deliver everything but generally get a trend and try to police requests. We cannot always deliver on all requests based on budget constraints and safety but the aim will be to stay true to the theme of Mapua through design. It would also depends on how much community ownership is taken. Takaka for example took ownership from the beginning.

Similar opportunities here, for example, Mapua school name a class to undertake opening, take ownership of a specific area, incorporate community art in the design, etc.

TDC would need feedback by 21 Jan

Glen will come back once he has 2-3 concepts to further discuss and get approval. Around 11 Feb meeting.

PATHWAYS	 Jessie St /Aranui Pathway Advised council that there is strong community support for pathway versus road. Contact Drake to see what he's thinking is. He was put off by notion towards a road rather than footpath and put in resources consent but might be more open to future development. Moreland St Pathway No reply received on letter send Mapua Drive crossing School signed off on that crossing and community at time wasn't in favor of it Letter to Jamie McPherson – Seaton/Valley Road pathway. Complaints about surface feeling it's not safe. Mapua Drive berm (area between road and path) complaints about look (overgrown grass etc.) of it. Question whether maintenance responsibilities lies with developer or TDC. Apparently area in front of houses was detailed in original design document to be maintained by developer to keep up with the look of the village. 	Chisnall
