The concerns regarding the AV equipment in the Bill Marris room have been discussed heavily throughout this year. We recently paid two technicians to come in and review the equipment and reprogrammed the system to ensure that the sound from the microphone, audio and visual projector all work in conjunction. It has been tested since and proved successful, there are currently no concerns with the performance of the equipment. The Hearing Loop has also been tested and recently re-evaluated, and rated in full working order as per council requirements for a public building.

The only concern we have with the system is that of cables being unplugged or moved which in turn causes the system to not work as it programmed to do so. Unfortunately buying more equipment will not solve this problem, the best remedy for this is through education on how to best connect to the system. We are currently in the process of simplifying the current 'AV Equipment Procedure' document which all users receive when they hire the equipment, with straightforward instructions on how to connect to the AV.
