Good afternoon.

Nelson City Council and Tasman District Council are working together to prepare the Nelson Tasman 2022 – 2052 Future Development Strategy (the FDS). The FDS assesses and sets out where and how residential and business growth within the Nelson and Tasman regions will occur over the next 30 years. The FDS is used to inform reviews and changes (such as zone changes) to Nelson City Council and Tasman District Council's unitary plans, to facilitate the next round of Long Term Plans (2024) including the Infrastructure Strategies, and to support business case work and future inter-council and central government funding partnerships. The FDS we are currently preparing will replace the July 2019 FDS.

We will be undertaking public consultation and seeking submissions on the draft 2022 – 2052 FDS between the 14th of March 2022 and 14th of April 2022.

Can you please advise if Nelson City Council and Tasman City Council can hold an online joint webinar (1 hour long) on the draft FDS, at the 14th of March 2022 Mapua Community Association meeting?

If so, can you please advise the time that the FDS team could join the Mapua Community Association meeting, and who usually sets up the zoom meetings?




