In order to continue to hold our Monthly Public Meetings in an inclusive and effective manner, and fully comply with Covid-19 regulations, MDCA has purchased higher quality microphones and speakers and is in the process securing a multi-year MDCA dedicated Zoom Subscription. Our previous use of the Free Zoom service was no longer an option given this service was limited to 40 mins max and our Public and Exec Meetings are typically 2 hours in duration. Also, while in the past maybe 1-2 members might have joined via Zoom, now 20+ members participate via Zoom, which an expectation that they can hear the proceeding clearly and engage in Q&A sessions.

The benefit to the Tasman Community will be MDCA continuing to engage with and be fully inclusive of its members, whether they chose to attend our public meetings in person or via Zoom. It is particularly important given the significant changes being proposed for our community in terms of residential development that MDCA can encourage and facilitate feedback from residents on critical matters such as the FDS, LTP, Annual Plan and Urban Provisions process, all of which are out for public consultation during CY2022/23.
