Thanks for the email and apologies that I haven't responded directly until now. We took a lot from the meeting and put the discussion points to our team for consideration.

At this stage of the Masterplan process, we are comfortable with the level of engagement and opportunities provided to the Māpua community. The engagement process utilised has given way to a myriad of feedback and responses being received, while reaching a wide cross section of those who live and/ or have an interest in the future planning for Māpua.

The actions and efforts carried out thus far have enabled us to identify and establish the key issues and areas of importance to be factored into the draft Masterplan, which will then be put out for public review in the coming weeks.

We still have submissions, hearings and deliberations to come before any final decisions are made. We will be increasing and maintaining our communication with the community as this rolls out as want to make sure that the remainder of the process offers plenty of information and understanding but crucially gives ample opportunity for the community to participate in the remaining steps.

We want to thank you for your offer to assist with engagement/ advocacy. It's always good to hear from and meet with people like yourself who suggest methods and ideas that can be considered so that projects and processes like this can be carried out for the benefit of all involved.
