NEXT STEPS

Staff are currently developing the draft masterplan. The draft masterplan is expected to be released later this year and will go through a Local Government Act consultation process which involves formal submissions, hearings and deliberations. Through this process submitters have the opportunity to speak to their submission and be heard by councillors at a hearing. A decision on the final masterplan will be made by full Council and a final masterplan released for implementation. It is intended that this process will be completed by the end of 2024.

We will release further communications when the draft masterplan is ready for public circulation.

Hello Anna,

At last night's MDCA meeting, there were questions from the floor regarding what is happening to this project.

When you have a moment, can you please put a few words together?

- What is the current status ? Refer above
- When is step 6, in the process due (circulate final draft for public review)? Refer above, we have no firm dates. We are currently working on the draft but we are unsure how long it will take until we have had a few key meetings with internal staff and iwi – these are scheduled for July.
- How long is the submission period? We have not determined this yet, it will be similar to other Local Government Act processes.
- Can you please provide a list of stakeholders ? We have a consultation register which includes a variety of community and environmental groups, government agencies, business representatives and landowner details – I think a request for this register would need to go through a LOGIMA process as personal contact details may need to be redacted.
