Kia ora,

Work to improve skid resistance on SH60, Motueka between Staples and Parker streets is planned on Sunday 6 October and Monday 7 October from 7pm to 5am.

This work requires a specialised truck to move through affected sites, applying high-pressured water onto the road. This increases the roughness of the road surface, improving safety for all road users. This process will be noisy. We apologise in advance for the inconvenience.

While the work is in place, stop/go controls and a temporary speed limit of 30km/hr will be in place for the safety of road users and our crew. Expect delays of up to 5 minutes.

Emergency Services will always be accommodated through the site.

Work to improve skid resistance will also be on SH60, The Coastal Highway between the south side of Appleby Bridge and Westdale Road is planned from 7pm to 5am each night between Tuesday 8 October and Thursday 10 October from 7pm to 5am.
