Thanks for getting back to me.

The Mapua Hall already has a number of noticeboards - these are largely dedicated to promoting upcoming events at the hall and are typically completely full of notices. The regular events hosted at the hall also largely cater for the seniors segment of our community.

The attraction of the Wharf area is that it gets a lot of foot traffic representing a much larger cross section of our community - so the goal of the noticeboard at that location is to post notices that impact all residents (youth, working-age, retirees, regular visitors).

Given this, when you have time (as I understand that this may not be urgent relative to your other duties) can you discuss with your colleagues which location at the wharf would be acceptable (to your team, Richard Hilton and the Road Safety team), and revert with a few pictures of the recommended options. That would be very helpful.

I have had a quick look at also spoken with our Reserves team.

Would the Mapua Community Hall be a better and more accessible location?

An alternative could be to affix it onto the Recycle Centre we have installed on Aranui Road but it would need to be balanced against road safety.

One of the exterior walls on the public toilets may be a possibility but this would need to go through Reserves. Richard Hilton in Parks and Reserves is a good point of contact for potential.

I have made a service request just to get this formally into the TDC system.

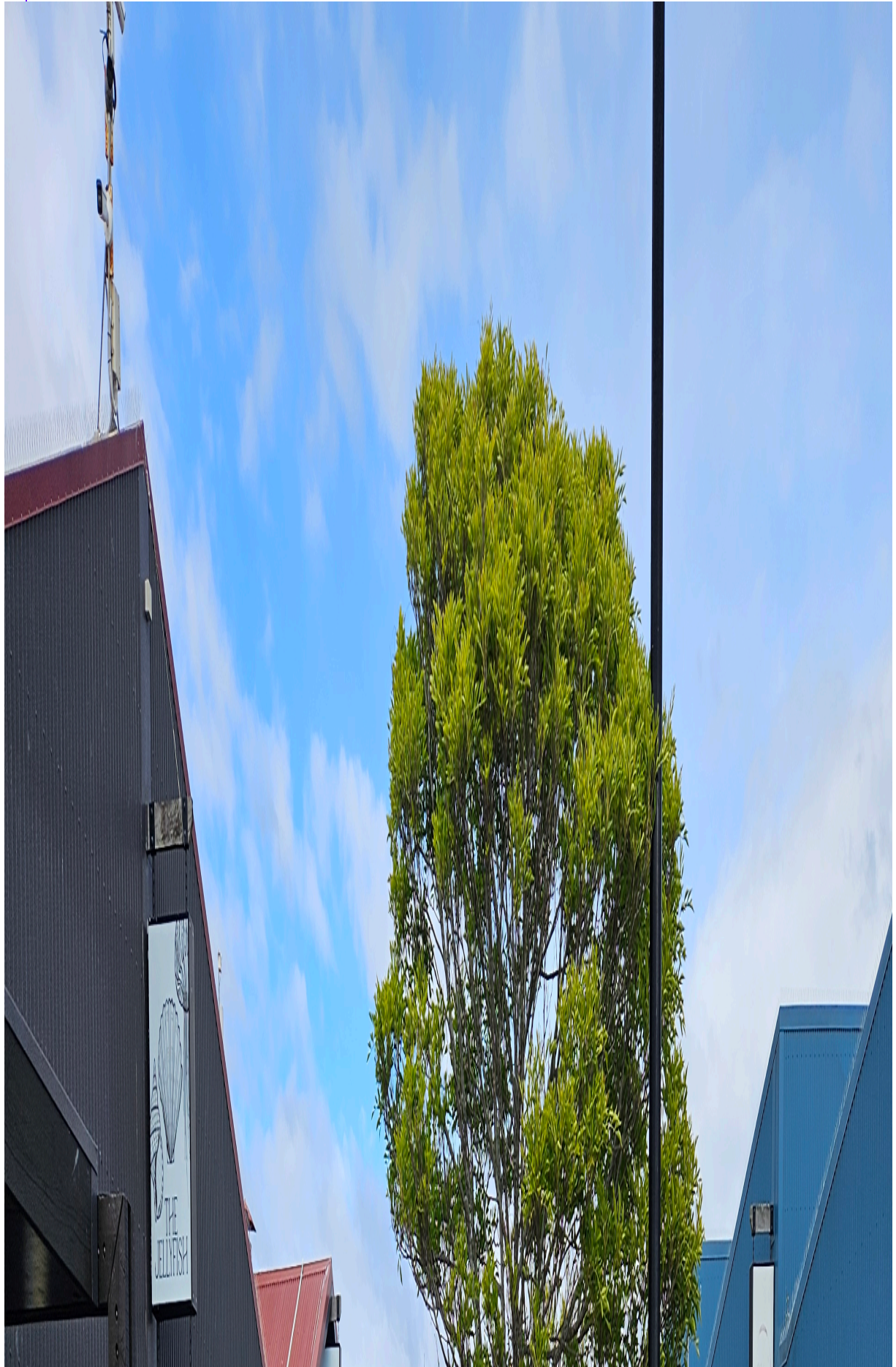
The intention is for a lockable all-weather board similar to the board outside of the Māpua Boat Club (see below)

some potential location - which may or may not be possible.















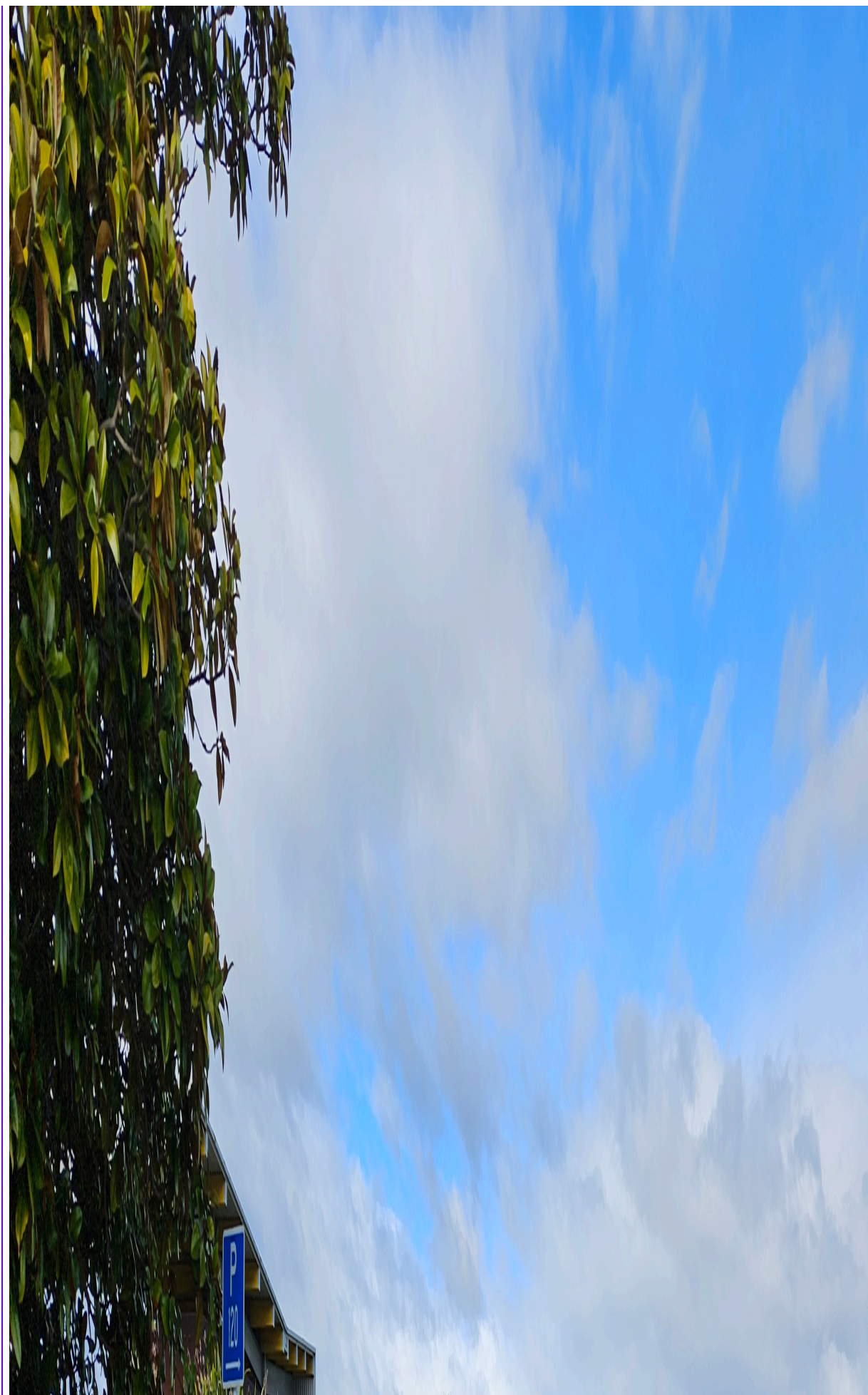








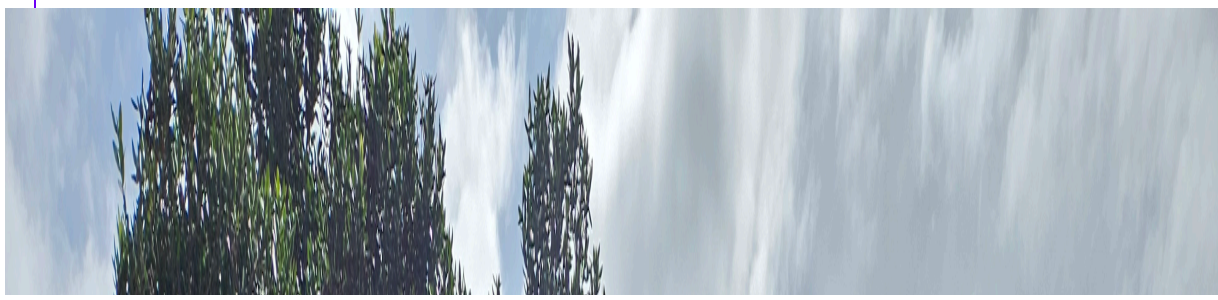




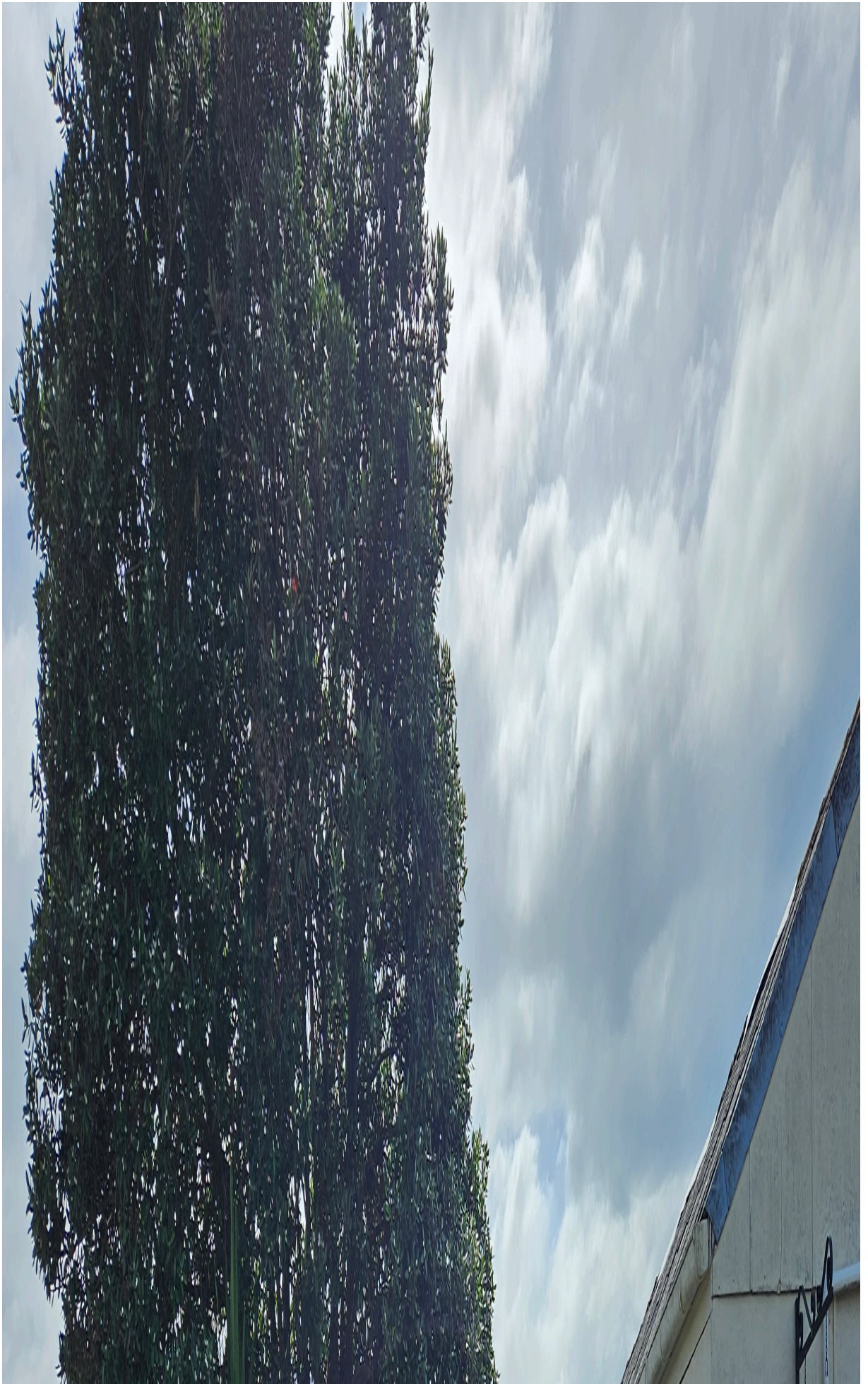








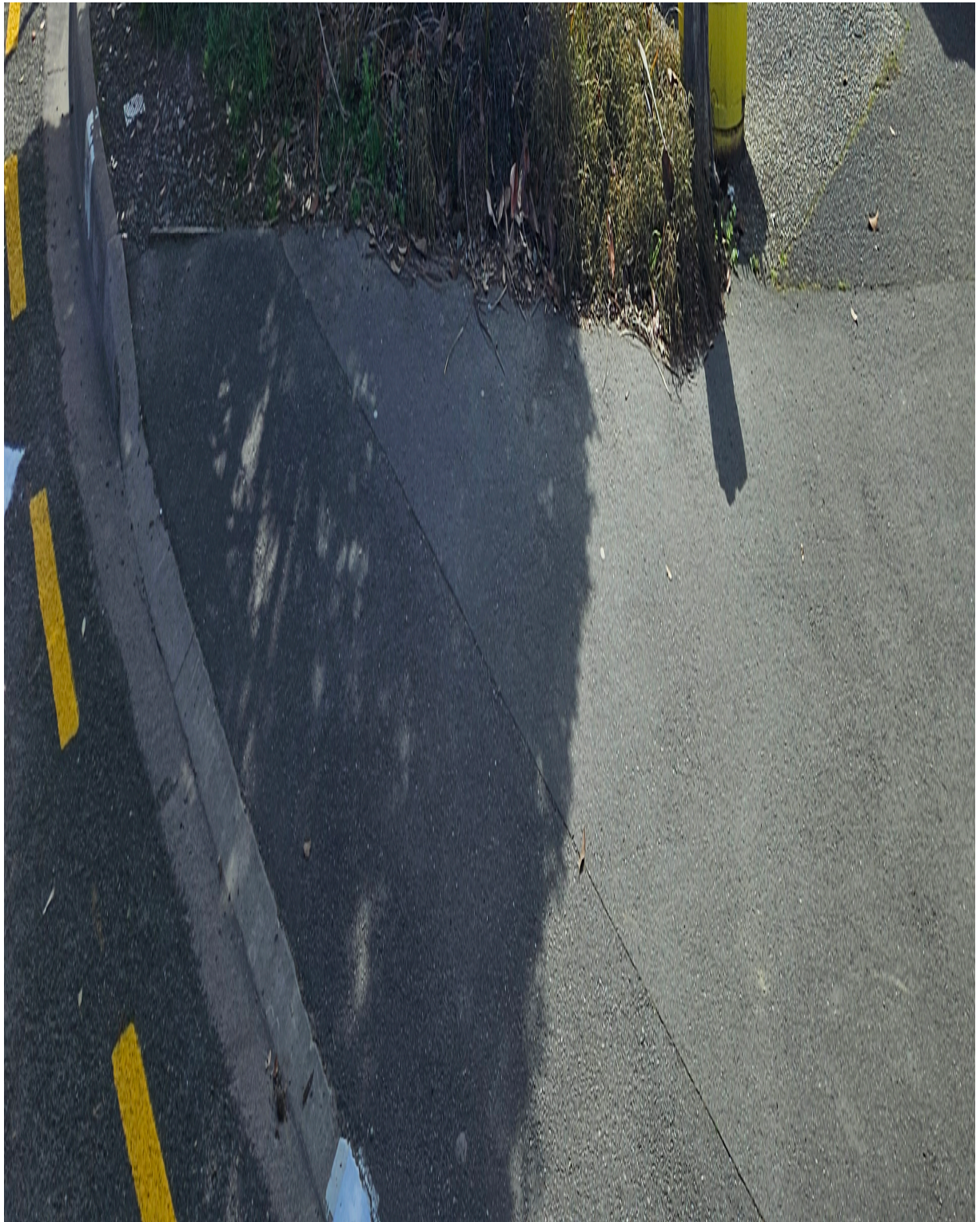












MDCA would be happy to maintain the noticeboard and contribute to costs, as well as coordinating notices.
